IN 2020, WE PROVIDED TEMPORARY HOUSING AT GIRARD STREET (WARD 1) FOR 30 FAMILIES WITH CHILDREN, AT HOPE APARTMENTS (WARD 8) FOR 13 FAMILIES WITH CHILDREN, AND SERVED 166
