IN 2017, WE SERVED 1,045 FAMILIES, INCLUDING 1,321 ADULTS AND 1,820 CHILDREN. WE OFFER HOMELESSNESS PREVENTION SERVICES THAT ASSISTED 566 FAMILIES, AND 85% OF THEM DID NOT END UP IN SHELTER.
