IN 2019, WE SERVED 1,228 FAMILIES, INCLUDING 3,960 PEOPLE. WE OFFER HOMELESSNESS PREVENTION SERVICES THAT ASSISTED 653 FAMILIES, AND 90% OF THE CASES DID NOT END UP IN SHELTER.
